Sub: Appointment on the post of Chairperson, Madhya Pradesh Electricity Regulatory Commission (MPERC) – Inviting applications.

Madhya Pradesh Electricity Regulatory Commission (MPERC) has been constituted with a Chairperson and two Members.

- 2. The present Chairperson of Madhya Pradesh Electricity Regulatory Commission is completing his tenure on 13.1.2020, thus the vacancy will arise from 14.1.2020. Therefore it is decided to invite applications from the interested eligible persons for selection to the post of Chairperson of Madhya Pradesh Electricity Regulatory Commission.
- 3. A selection committee is being constituted by the State Government under sub section (1) of section 85 of the Electricity Act, 2003 (No. 36 of 2003).
- 4. In term of sub section (1) of section 84 of the Electricity Act,2003, the Chairperson of MPERC shall be a person of ability, integrity and standing who has adequate knowledge of, and has shown capacity in, dealing with problems relating to engineering, finance, commerce, economics, law or management. As per Sub-section 1 of Section 89 of the Electricity Act, 2003, the person finally selected for appointment on the post of Chairperson, MPERC, shall hold office for a term of five years from the date he/she assumes the charge or till he/she attains the age of 65 years, whichever is earlier.
- 5. The person finally selected for appointment on the post of Chairperson of MPERC shall get Rs. 2,25,000/- (fixed) per mensem. Other allowance and terms and conditions of service of Chairperson shall be as per Section 89 of the Electricity Act,
