Sub:- Selection for the post of Member in the Haryana Electricity Regulatory Commission – Invitation for applications – Regarding.

The Haryana Electricity Regulatory Commission (HERC) was constituted in 1998 with a Chairman and two Members under the Haryana Electricity Reforms Act, 1997 to regulate the Electricity Industry in the State. One post of Member, HERC would fall vacant on 10.09.2018 i.e. on completion of term of present Member Sh. M.S. Puri on 09.09.2018. A suitable person has to be selected for this post and a Selection Committee has been constituted for this purpose.

- 2. As per directive of Hon'ble Supreme Court of India vide judgement dated 12.04.2018 in the Civil Appeal no. 14697 of 2015, one member of the State Commission should be a person, who is, or has been holding a judicial office or is a person possessing professional qualifications with substantial experience in the practice of law, who has the requisite qualifications to have been appointed as a Judge of the High Court or a District Judge.
- 3. The selected member shall hold office for a term of five years from the date he enters upon his office provided that no member shall hold office as such after he has attained the age of sixty five years, as provided in Section 89 of the Act.
- As per Rule 3 of the Haryana Electricity Regulatory Commission (Conditions of service of Chairman and Members) Rules 1998 and amended vide notification dated 20.05.2009, pay of Members shall be in the HAG plus Scale of Rs. 75,500 80,000- per month with grade pay nil and an annual increment at the rate of 3% subject to deduction of the gross amount of pension including any commuted portion thereof if already getting.

  - A) The bio-data of the proposed candidate should include the following details alongwith his/ her signature and date:

    - iii) Position now held

    - v.) Details of posts previously held and experience in the field of law.

- B) The proposal should contain a letter from the person proposed intimating the details of any office, employment or consultancy agreement or arrangement which he/she has in his/her own name or in any firm, association or persons or body corporate, or in the names of any relative, carrying on any of the following business, namely:-

- C) In addition to the above data, proposal should also include a letter of willingness to resign his/her post and to join HERC if selected.
- D) A declaration in the form of undertaking is also required to be submitted along with the application on the following points:
  - i) That he/ she does not have any financial or other interest which is likely to affect prejudicially his/ her function as Member, Harvana Electricity Regulatory Commission.
  - ii) Whether any criminal case has been registered against applicant?
  - iii) Whether applicant has been charge-sheeted for any criminal offence? If yes, the details thereof.
  - iv) Whether applicant has been convicted by any competent court for any criminal offence? If yes, the details thereof.
