Sir,

The Haryana Electricity Regulatory Commission (HERC) was constituted in 1998 with a Chairman and two Members under the Haryana Electricity Reforms Act, 1997 to regulate the Electricity Industry in the State. The post of the Chairman would be vacant in HERC on 12.08.2019 due to completion of the tenure of the current Chairman. The qualifications for appointment of Chairman of State Commission and his terms of office and conditions of service are provided in Section 84 and 89 of the Electricity Act, 2003, respectively. Pay and allowances of Chairperson of the State Commission have been provided in Rule-3 of the Haryana Electricity Regulatory Commission (Conditions of service of Chairman and Members) Rules, 1998 as amended from time to time. An extract of Section 84, 89 of the Electricity Act, 2003 and Section-3 of the aforementioned rules is enclosed, for ready reference.

- 2. As per Section 84 of the Electricity Act 2003, the Chairperson of the State Commission shall be person of ability, integrity and standing who has adequate knowledge of and has shown capacity in, dealing with problems relating to engineering, finance, commerce, economics, law or management. The Chairperson of the State Commission shall not hold any other office as provided in sub-section (3) of Section 84 of the Electricity Act, 2003.
- 3. The Chairperson shall hold office for a term of five years from the date he enters upon his office provided that no Chairperson shall hold office as such after he has attained the age of sixty five years, as provided in Section 89 of the Act.
- 4. As per Rule 3 of the Haryana Electricity Regulatory Commission (Conditions of service of Chairman and Members) Rules 1998 as amended from time to time, the Chairman shall receive a pay in the apex scale of Rs. 2,25,000/- (Fixed) per month in the pay matrix level 17 (corresponding to the pay scale of Rs. 80,000/-).
