- (4) The eligible and suitable candidates must apply through their parent department. Their application must reach in the office of HSPCB, C-11, Sector-6, Panchkula by **01.10.2026. Applications sent directly will not be entertained.**
- (5) The applications **in prescribed proforma** of eligible and interested officials, alongwith a certificate to the effect that they are clear from Vigilance angle, their integrity certificate, details of major/minor penalty imposed on them and attested photocopies of their ACRs/APARs for the last 5 years, be forward to the Haryana State Pollution Control Board, C-11, Sector-6, Panchkula by **01.10.2026.**
