Subject:- Regarding filling up the one post of Research Officer in HBPE (FD) i.e. unit of ERAMU in Haryana Civil Secretariat on transfer basis.

Reference Government Memo No. 22/40/2001-6Estt.-I, dated 02.09.2022 on the subject noted above.

2 It is again informed that one post of Research Officer (Group 'B') is in the Pay Matrix, Schedule-I, Level-8 of Haryana Civil Services (Revised Pay) Rules, 2016 is proposed to be filled up in HBPE (FD), Haryana Civil Secretariat on transfer basis amongst the Research Officers having following qualification and experience:-

- i) Clear Photostat copies of their ACR for the last 10 years i.e. from 2012-2013 to 2021-2022 duly attested by Group "A" officer.
- ii) Integrity Certificate.
- iii) Certificate confirming that no disciplinary/ vigilance case pending or being contemplated against the officer.
- iv) A statement showing major or minor penalties, if any, imposed on the applicant during the last 10 years.

2. Application received after the closing date or without the Photo state copies of ACR duly attested by a Group "A" Officer or without recommendation of the concerned office or otherwise found incomplete are liable to be rejected. While forwarding the applications, it may be verified the certificate and particulars furnished by the official are correct in all respect. It may also be confirmed that in the event of selection for appointment, the officer concerned will be immediately relieved to join him/ her new assignment.
