In continuation to this office memo No. Ch-51/HPG/Genl-557 dated 01.07.2022, the Tentative Seniority list of Persons with Disabilities (PWD) employees of HPGCL working/retired from Group-A & B from 14.08.1998 to till date is enclosed herewith as **Annexure-A** after considering the representations received from Sh. Dharmender, AE, Sh. Randhir Singh, AE (Retd.), Sh. Neel Kumar Pahwa, AEE, Sh. Sandeep, AE and Sh. Naval Dhillon, AO on the tentative List circulated vide reference above.

Sh. Sandeep, AE submitted his medical certificate, issued on 20.07.2022, wherein he has been declared overall hearing disability as 30% (thirty percent). Thus he is not eligible for granting the benefit of reservation in promotion in terms of State Govt. instructions dated 25.03.2022. Accordingly, his name is removed from the Tentative Seniority list of Persons with Disabilities (PWD) employees of HPGCL as per State Govt. instructions dated 25.03.2022.

In case any other employee/retiree of HPGCL wish to claim his promotion under Persons with Disabilities (PWD) as per State Govt. instructions in HPGCL who had filed any claim during this period but his/her name is not mentioned in the ibid list, he / she may also submit supporting documents i.e. proof of submission of PH certificate to the department/order of conveyance allowance for handicapped employees if any, against his claim within 30 days alongwith latest disability certificate issued through Govt. of India Unique Disability ID portal i.e www.swavlambancard.gov.in.
