## **CORRIGENDUM:** NOTICE TO APPLICANTS

Advt. No.: HPU/Part-I/2015/II

**Ref:** Advertisement No. HPU/Part-I/2015 dated 14.07.2015 published in Hindustan Times / Hindustan Hindi / Tribune / Dainik Jagran & Employment News dated 18-24 July 2015 for the posts of Assistant Engineer (Electrical / Mechanical / Instrumentation / IT / Electronics / Civil ) & UDC (IT) in Haryana Power utilities viz. DHBVN, HPGCL, HVPN, UHBVN.

In pursuance of orders dated 27.07.2015 of the Hon'ble Punjab and Haryana High Court passed in CWPs No. 2441, 6076, 13150 of 2014 & 9132 of 2015 and notification issued by the Chief Secretary, Govt. of Haryana vide No. 22/149/2015-GS-III dated 21.08.2015, it is hereby informed that the candidates who had applied against Advertisement No. HPU/Part-I/2015 under Special Backward Classes Category for various posts their candidature will be provisional subject to the final outcome of the aforesaid pending writ petitions in the Hon'ble Punjab and Haryana High Court and further subject to the following conditions:

- 1. In the case of those Special Backward Classes candidates who competed without benefit of age relaxation, against general vacancies and succeeded on merit, their result will be declared.
- 2. In case the aforesaid writs are not decided till the recruitment process is over and result is ready to be declared then the result of the Special Backward Classes candidate shall be withheld till the decision of the aforesaid writs. In case the Special Backward Classes reservation notification is quashed then these Special Backward Classes candidates result will be null and void.

Besides the above, the following is also informed to candidates:

- 1. All prospective candidates as well as candidates, who have already applied in the earlier advertisements relating to Part-I of the special recruitment are informed by way of this Corrigendum that
  - a) The list of the candidates eligible for appearing in the Written Examination would be prepared purely on the basis of the marks obtained by the candidates in the qualifying examination as indicated in the earlier advertisement. The candidates numbering 20 times the post of particular category would only be eligible for Written Test.
  - Any candidate, who had not applied earlier, may also apply now. But the candidates who had earlier applied against earlier advertisement need not apply again. His/her earlier application would be considered.
  - c) The candidates numbering two times the posts advertised would be short listed for interview on the basis of the merit list to be prepared purely on the basis of the marks obtained in the Written Exam.
- 2. In view of above, online applications from eligible Indian nationals for advertised posts is invited from 30.01.2016 to 20.02.2016.
