In exercise of powers conferred under Section 56 (3) (vi) of Haryana electricity Reform Act,1997 read with Electricity Act,2003 and all other enabling powers in this behalf, the Haryana Power Generation Corporation Limited is pleased to make the amendment in Sub Regulation-9 (2) of the PSEB Service of Engineering (**Electrical**) Regulation, 1965 (as applicable in HPGCL) notified vide office order No. 35/REG-25A/PSEB dated 01.09.1965 read with office order no.21/REG-18 dated 19.02.1988 and other amendments thereof, to the extent as under:-

<p>Regulation-9 (2) Subject to the provisions of Regulation-9 (1) above, an AE, whether promoted from amongst Engineering Subordinates or directly recruited, will, henceforth be eligible for promotion to the post of AEE, XEN and SE on seniority-cum-merit basis, provided that no Xen, so promoted shall be eligible for promotion to the rank of Superintending Engineer unless he holds a degree in Electrical, Mechanical or Electronics Engineering or AMIE/BE degree.</p>	<p>Regulation-9 (2) Subject to the provisions of PSEB services of Engineers (Electrical), Recruitment Regulation, 1965 amended from time to time, an Assistant Engineer, whether promoted from amongst engineering subordinates or directly recruited, will henceforth be eligible for promotion to the post of Assistant Executive Engineer, Executive Engineer and Superintending Engineer on seniority-cum-merit basis.
