Kindly refer to this office memo no. Ch-46/HPG/Genl.-119/Loose dated 22.07.2016 (copy enclosed) vide which the Tentative Seniority List of JE's of 1989 batch onward upto 14.08.1998 i.e. till the unbundling of HSEB (without prejudice to the court cases) starting with Sh. Gulshan Kumar (Spl. Seniority No. 1) and ending with Sh. Bakshi Ram (BC) (Spl. Seniority No. 702) was circulated & hosted on the official websites of all Haryana Power Utilities and a period of 30 days (i.e. upto 21.08.2016) was given to concerned officers/officials/retirees to submit their legitimate grievances if any.

In this regard, it is intimated that the period for inviting legitimate grievances on the Tentative Seniority List of JE's circulated vide letter dated 22.07.2016 is hereby curtailed from 30 days (from the date of issue i.e. upto 21.08.2016) to 08.08.2016, in view of the next date of hearing being on 17.08.2016 in the COCPs.

Accordingly, the above may be got noted from all concerned officers/officials/Retirees in your jurisdiction.

In case no representation is made by the concerned officer/official/retiree, within the stipulated period i.e. upto 08.08.2016, it will be presumed that he/she has accepted the seniority position assigned to him/her as correct. Any representation received thereafter shall not be considered.

The committee will analyze all the representations so received and will submit final seniority list latest by 10.08.2016, after incorporating all the changes clearly mentioning the reasons, alongwith documentary evidence(s).

Comments of your corporation be also given by 09.08.2016 i.e. before preparing final seniority list *please*.
