Technical Assistant Pay Matrix Level-4 (Group-C)	By deputation- (i) Matric with ITI Certificate holder (Mechanical or Fitter or Motors or Electrical or Turner); (ii) Five years experience as Technical Assistant; and (iii) Hindi or Sanskrit up to Matric Standard or Higher Education. Note- Candidate possessing higher qualifications than minimum qualifications prescribed for the post, shall be considered eligible.


