

c)	Age	Not more than 60 years as on 01.11.2022
d)	Wages	As per provisions of Rule-52 of Chapter-XI contained in Haryana Civil Services (Pay) Rules – 2016 (applicable for retired Chief Engineers & Technical Directors)
e)	Other terms & conditions	His services can be dispensed with, if work and conduct it not found satisfactory at any stage, without any notice. He will be provided free institutional accommodation, if available or society leased accommodations as admissible to Director, HVPNL. No other allowances will be admissible.
