Filling up the post of Chief Scientific Engineer on deputation basis in Haryana Renewable Energy Development Agency (HAREDA).

1. The Haryana Renewable Energy Development Agency (HAREDA) intends to fill up the post of Chief Scientific Engineer in FPL-13 on deputation basis from already working Executive Engineers & above rank officer in Haryana Power Utilities.

2. Applications of only those applicants will be considered:-

- (i) which will be routed through proper channel;
(ii) Attested summary of ACRs of the last ten years; and
(iii) Certificate to the effect that they are clear from vigilance / disciplinary angle, Integrity certificate and a statement showing major/ minor penalties imposed in last 10 years, if any.

3. The last date for submission of applications shall be two months from the date of issue of letter. No application received after the due date shall be entertained.

4. Initially, the term of deputation shall be one year from the date of joining, extendable for three years subject to performance of the officer which may be curtailed at any time by the competent authority without assigning any reason or opportunity. The other terms & conditions of the persons appointed on deputation shall be governed by the rules/ regulations issued by the Government from time to time.
