I am directed to address you on the subject cited above and to inform you that State Information Commission, Haryana has been observed that different public authorities provide information to RTI applicants in different formats. Though there cannot be a standard format for providing information, the reply should however, essentially contain the following information:

RTI Application number with date and date of its receipt in

the public authority.

The name, designation, official telephone number and email

ID of the SPIO.

In case the information requested for is denied, detailed reasons for denial quoting the relevant section of the RTI Act should be clearly mentioned.

In case the information pertains to other public authority and the application is transferred under section 6(3) of the RTI Act, then details of the public authority to whom the RTI application has been transferred should be given.

In case additional fee is sought, provision of Rule 4(4) and 5(2) should invariable be intimated to the citizen seeking information including the right of appeal against the decision

of SPIO.

Where the SPIO intends to disclose any information or record or part thereof on a request made under this Act, which relates to or has been supplied by a third party and has been treated as confidential by the third party, the SPIO is obliged to proceed as per Section 11 of the RTI Act, 2005 to take a decision about sharing of information pertaining to third party.

 - (3) A copy of the order of the Commission imposing penalty on a State Public Information Officer shall be forwarded to the Registrar. After receipt of such order, the Registrar shall enter the details thereof in a register maintained for the purpose in Form'C'.
 - (4) The penalty order shall be conveyed by the Registrar vide a letter in Form 'D' to the controlling authority concerned for recovery of the penalty amount from the salary of the State Public Information Officer and for the deposit of this amount in the following head of account, by the date fixed namely:-

No. S.O. 99/C.A. 22/2005/S. 27/2009.—In exercise of the powers conferred by sub-section (1) read with sub-section (2) of section 27 of the Right to Information Act, 2005 (Act 22 of 2005), the Governor of Haryana hereby makes the following rules providing for information under the said Act, namely:—

Short title and commencement.

- 1. (1) These rules may be called the Haryana Right to Information Rules, 2009 commencement.
 - (2) They shall come into force from 1st January, 2010.

Definitions

- 2. (1) In these rules, unless the context otherwise requires,
 - (a) "Act" means the Right to Information Act, 2005 (Act 22 of 2005);
 - (b) "Commission" means the Haryana Information Commission, constituted under section 15 of the Act;
 - (c) "Model Form" means a model form appended to these rules;
 - (d) "section" means the section of the Act.
- (2) The words and expressions used in these rules, but not defined, shall have the same meanings as respectively assigned to them in the Act.

Application for obtaining information sections 2(m), 6 and 27

- 3. (1) A person who desires to obtain any information admissible under the Act, shall make an application, preferably in Model Form 'A' to the State Public Information Officer and in his absence to State Assistant Public Information Officer along-with fee as specified in sub-rule (1) of rule 5 of these rules.
- (2) On the receipt of an application, made under sub-rule (1), the State Public Information Officer or State Assistant Public Information Officer as the case may be, shall give a receipt in token thereof to the applicant.

Deposit of fee.

4. (1) The fee shall be deposited with the State Public Information Officer either in Cash against proper receipt, by Bank Draft, by Indian Postal Order or by Treasury Challan in the following Heads of Account:—

"0670—Other Administrative Services—60— Other Services—800—Other Receipts—86—Fee under the Right to Information Act, 2005".

(2) The amount of fee shall be credited to the account as referred in sub-rule (1);

Provided that the Boards, Corporations and other autonomous bodies of the State may get the amount of requisite fee deposited in their own accounts maintained by them.

- (3) On receipt of an application, submitted under sub-rule (1) of rule 3, the State Public Information Officer shall scrutinize the application and shall assess how much fee is required to be paid by the applicant for obtaining the information.
- (4) The fee assessed under sub-rule (3), shall be intimated to the applicant by the State Public Information Officer, expeditiously, in Model Form 'B' to ensure the delivery of information within time specified under subsection (1) of section 7 of the Act.
- (5) In case the applicant fails to deposit the requisite fee within a period of fifteen days after the issuance of the intimation given to him under subrule (4), it shall be construed that the applicant is no longer interested in obtaining the information sought for and his application shall be deemed to have been filed.
- 5. (1) An application for obtaining any information under subsection (1) of the section 6 shall be accompanied with a fee of Rs. 50/-.

Quantum of fee. sections 6 and 7

- (2) For providing information under sub-section (1) of section 7, the fee shall be charged from the applicant at the following rates, namely:—
 - (a) Rs. 2/- for each page in A-4 or A-3 size paper, created or copied; and
 - (b) if information is to be provided on a large size of paper than that specified in clause (a), the actual cost shall be charged.
- (3) For providing information under sub-section (5) of section 7, the fee shall be charged from the applicant at the following rates, namely:-
 - (a) Rs. 50/- for providing information in a floppy;
 - (b) Rs. 100/- for providing information in diskette; and
 - (c) if information sought is of such a nature, which is contained in a printed document, of which a price has been fixed, then that information shall be provided after charging the price, fixed for that printed document. However, if only an extract or page of such a printed document is asked for, then a fee of Rs. 2/- per page shall be charged.
- (4) No fee for inspection of record shall be charged, if such an inspection is made for one hour only. However, if inspection is made for a period of more than

one hour, then a fee of rupees ten shall be charged for every fifteen minutes in excess of first hour. Every fraction of the period above fifteen minutes shall be construed as a complete period of fifteen minutes and it shall be charged as full period of fifteen minutes.

Procedure for filing appeals. sections 19(1) and (3)

- 6. (1) The memorandum of appeal shall contain the following information, namely:—
 - (a) name and address of the appellant, including the details of contact telephone/mobile Numbers/e-mail address, if any;
 - (b) official designation and address of State Public Information Officer or State Assistant Public Information Officer, as the case may be;
 - (c) official designation and address of the Officer against the decision of whom the appeal is preferred;
 - (d) particulars of the order including number, if any, against which the appeal is preferred;
 - (e) brief facts leading to the appeal
 - (f) prayer or relief sought;
 - (g) grounds for the prayer or relief
 - (h) verification by the appellant; and
 - (i) any other information which the Commission may deem necessary for deciding the appeal.
- (2) The appellant shall submit three copies of the memorandum of appeal for official purpose.
- (3) Every appeal made to the Commission shall be accompanied by the following documents, namely:—
 - (a) self attested copies of the Orders or documents against which the appeal is being preferred;
 - (b) copies of documents relied upon by the appellant and referred to in the appeal; and
 - (c) an index of the documents referred to in the appeal:

Provided that in case complete documents are not furnished, the appeal shall not be rejected but the appellant shall be asked to complete the above formalities.

Procedure for deciding appeal. section 19(10)

- 7. Before deciding an appeal, the Commission shall,—
 - (a) serve notice to the concerned persons;
 - (b) entertain any evidence in support of appeal, which may be oral or in writing from the concerned persons;

- (c) examine on oath or an affidavits from the persons concerned;
- (d) examine the documents or any records or copies thereof;
- (e) inquire through the authorized office the facts of the appeal or may require facts in detail, if he so deems appropriate, hear the State Public Information Officer or any other senior officer who had decided the first appeal, as the case may be; and
- (f) receive evidence on affidavits from the State Public Information Officer or any senior officer who had decided the appeal or from any other person from whom the evidence may be deemed necessary.
- 8. The Commission may serve notice to the persons concerned in any of Mode of the following modes, namely:-

serving notice. section 19(10)

- (a) by hand delivery (dasti) through process server;
- (b) by Registered Post, Speed Post, Under Postal Certificate, Courier or such other means;
- (c) by electronic mail, if e-mail address is provided; or
- (d) by publication in the newspaper.
- 9. The appellant or the complainant, as the case may be, shall in every Appearance of case be informed of the date of hearing at least 15 clear days before that date. If the Appellant case be informed of the date of nearing at least 13 clear days before that date. If the complainant/appellant fails to appear on the date of hearing, the Commission will Section 19 decide the matter on merits:

Provided that where the Commission is satisfied that the circumstances exist due to which the complainant or appellant is being prevented from rattending the hearing, then, he may afford the complainant or appellant another opportunity of being heard before taking a final decision.

10. (1) The Commission shall make order in writing and pronounce the same in the presence of the concerned parties.

Order by Commission section 19(10)

- (2) The party concerned may obtain the copy of the order from the Commission.
 - 11. The Haryana Right to Information Rules, 2005 are hereby repealed:

Repeal and Saving.

Provided that any order made or action taken under the rules so repealed shall be deemed to have been made or taken under the corresponding provisions of these rules.

I am directed to address you on the subject cited above and to inform you that State Information Commission, Haryana has noticed that in many cases following deficiencies has been noticed by the Commission while deciding appeals/complaints:-

The first Appellate Authorities under the Right to Information Act, do not dispose of the appeals within the time frame prescribed by the Act; The Appellate Authorities do not examine the appeals judiciously and

apperlish subsente and appliate exacting

The Appellate Authorities do not examine the appeals judiciously and express their agreement with the decision of the State Public Information Officer mechanically;

The State Public Information Officer do not comply with the directions of the first Appellate Authority to furnish information to the appellant; Sometimes the appeals are not heard by the appellate authority themselves.

Section 19(6) of the RTI Act provides that the first Appellate Authority should dispose off the appeal with in thirty days of the receipt of the appeal. In exceptional cases, the appellate authority may take forty five days to dispose off the appeal subject to the condition that he shall record in writing the reasons for delay in deciding the appeal. Therefore, each first appellate authority should ensure that an appeal received by him is disposed off within 30 days of the receipt of the appeal. If, in some exceptional cases, it is not possible to dispose off the appeal within 30 days, its disposal should not take more than 45 days. In such cases, the appellate authority should record, the reasons for not deciding the appeal within 30 days.

Deciding appeals under the RTI Act is a quasi-judicial function. It is therefore, necessary that the appellate authority should see to it that the justice is not only done but it should also appear to have been done. In order to do so, the order passed by the appellate authority should be speaking order giving justification for the decision arrived at.

4. If an appellate authority comes to a conclusion that the appellant should be supplied information in addition to what has been supplied to him by the SPIO, he may either (i) pass an order directing the SPIO to give such information to the appellant; or (ii) he himself may give information to the appellant while disposing off the appeal. In the first case the appellate authority should ensure that the information ordered by him to be supplied is supplied to the appellant at the earliest. It would

however, be better if the appellate authority chooses the second course of action and he himself furnishes the information along with the order passed by him in the matter.

The State Information Commission has also pointed out that some of the Departments have appointed very junior officer as appellate authorities who are not in a position to enforce their orders The Act provides that the first appellate authority would be an officer senior in rank to the SPIO. Thus, the appellate authority, as per provision of the Act, would be an officer in a commanding position vis-à-vis the SPIO. Nevertheless, if, in any case the SPIO does not implement the order passed by the appellate authority and the appellate authority feels that intervention of higher authority is required to get his order implemented, he should bring the matter to the notice of the officer in the public authority competent to take action against the SPIO. Such competent officer shall take necessary action so as to ensure implementation of the provisions of the RTI Act.

You are therefore, requested to bring the above in the notice of all concerned/SPIOs under your control for compliance.

It has further been observed that in order to implement Right to Information Act, 2005 in letter and spirit, it is essentially required that following steps needs to be taken by each public authority to address the issue:-

- 1. Public Authorities should make the obligations mentioned in section 4, an integral part of their organizational functioning.
- 2. Annual various annual returns, Administrative reports, information/charts of the Departments alongwith date-wise replies given to the important questions of Vidhan Sabha and Parliament alongwith note for pads may be put up on the websites of the public authorities.
- 3. A dedicated senior officer preferably of the level of Additional Director must be designated to implement the provisions of Section 4 of the Act.
- 4. A comprehensive pro-active monitoring and enforcement mechanism needs to be set-up to ensure compliance of Section 4 of the Act. Administrative -2- Secretary of each department must comprehensively audit the implementation of Section 4 in each public authority under his control twice every year in the month of January and July and submit the reports to your office with a copy to the Commission. Their observations and orders must be put on the websites of the public authorities.
- 5. Enough resources should be made available to the field officers for computerization and up keep of record.

Sir/Madam,

I am directed to invite your attention to this Department's Notification No. 5/52/2016-1AR dated 03.07.2018 vide which Government had made amendment in rule 10 of Haryana Right to Information Rules, 2009 that Commission at the time of deciding any complaint/appeal may impose penalty on SPIO in accordance with the provisions of section 20 of the Act. The penalty order shall be conveyed by the Registrar to the controlling authority concerned for recovery of the penalty amount from the salary of the SPIO and for the deposit of this amount in the relevant head of account.

Now, it has come to the notice of the Government that despite efforts made by the Registrar of SIC and follow up with the Controlling Authorities concerned for recovery of the penalty amount from the salary of the State Public Information Officers, the pace of recovery is not encouraging.

Government has taken serious view of this lapse on part of the controlling authorities and decided that in case the amount of penalty is not recovered from the concerned State Public Information Officer, the Drawing and Disbursing Officer will be held responsible for this lapse and strict action will be taken against him/her as per provision made in Haryana Civil Services (Punishment and Appeal) Rules, 2016. All the Drawing and Disbursing Officers are directed to recover the penalty amount from the salary of the concerned State Public Information Officers and send a compliance report to Registrar, State Information

Commission, Haryana.

 - (4) The penalty order shall be conveyed by the Registrar vide a letter in Form 'D' to the controlling authority concerned for recovery of the penalty amount from the salary of the State Public Information Officer and for the deposit of this amount in the following head of account, by the date fixed namely:-



Sir/Madam,

I am directed to invite your attention to this Department letter of even number dated 02.08.2019 vide which instructions regarding recovery of penalty imposed under the provision of Right to Information Act, 2005 were issued. It was decided that in case the amount of penalty is not recovered from the concerned State Public Information Officer, the Drawing and Disbursing Officer will be held responsible for this lapse and strict action will be taken against him/her as per provision made in Haryana Civil Services (Punishment and Appeal) Rules, 2015. All the Drawing and Disbursing Officers were directed to recover the penalty amount imposed by State Information Commission, Haryana from the salary of the concerned State Public Information Officers and send a compliance report to Registrar, State Information Commission, Haryana.

It was also decided that controlling authorities may not issue Last Pay Certificate/No Dues Certificate to such SPIOs till he/she deposits the amount of outstanding penalty and to recover the amount of penalty out of pension from such officer/official who have retired without deposing the amount of penalty imposed under the RTI Act, 2005.

It has come to the notice of the Govt. that above, instructions are not being complied with seriously and the Govt. has taken serious note of it. Now, it is again reiterated that these instructions may be complied with, effectively otherwise strict view of the default will be taken.

This may kindly be noted by all concerned for its strict compliance.



Sir/Madam,

I am directed to refer to this Department letter No. 5/4/2002-1AR, 04.02.2019 on the subject cited above, vide which it was conveyed that for implementation of Section-4 of RTI Act, 2005 the following steps needs to be taken by each public authority to address the issue:-

(i) Public Authorities should make the obligations mentioned in section 4, an integral part of their organizational functioning.

Annual Administrative reports, various annual returns, critical information/charts of the Departments alongwith date wise replies given to the important questions of Vidhan Sabha and Parliament alongwith note for pads may be put up on the websites of the public authorities.

A dedicated senior officer preferably of the level of Additional Director must be designated to implement the provisions of Section 4 of the Act.

A comprehensive pro-active monitoring and enforcement mechanism needs to be set up to ensure compliance of Section 4 of the Act. Administrative Secretary of each department must comprehensively audit the implementation of Section 4 in each public authority under his control twice every year in the month of January and July and submit the reports of your office with a copy to the Commission. Their observations and orders must be put on the websites of the public authorities.

(v) Enough resources should be made available to the field officers for computerization and up keep of record.

To take immediate steps for maintaining all its records duly catalogued and indexed in manner and form which facilitates the right to information under this Act and ensure that all records that are appropriate to be computerized are, within a reasonable time and subject to availability of resources, computerized and connected through a network all over the country on different systems so that access to such records is facilitated.
