In this regard, it is intimated that applications from eligible Superintending Engineers having 12 years of service as Executive Engineers are invited for filling up the post of Chief Electrical Inspector (Electrical) in the office of Chief Electrical Inspector, Haryana Chandigarh on deputation basis, as per details mentioned below:-

3. QUALIFICATION AND EXPERIENCE

As per prevailing Haryana Electrical Inspectorate Service Rules, the officer should possess academic qualification and experience as mentioned against each:-

Designation of Post	Academic qualifications and experience if any, for appointment other than by direct recruitment
Chief Electrical Inspector	i) Degree in Electrical Engineering from a recognized university or its equivalent; ii) Twelve years of experience as Executive Engineer.

4. TERMS & CONDITIONS

All terms and conditions of deputation would be same as prescribed in the Haryana Civil Service Rules, 2016 as amended from time to time by the State Government, Haryana.

5. PROCEDURE FOR POSTING ON DEPUTATION

The eligible and interested employee are required to apply for the post on deputation within a period of one month from the date of issue of notice (before 27th of Nov 2021). The application should be sent through the Administrative Head of the concerned Department/ Agency/ Utility. Application/name forwarded directly by any authority/person other than Administrative Head of the concerned Department will not be entertained.


6. DURATION OF SERVICE ON DEPUTATION

Initially the deputation will be for one year to be extended for three years after review on yearly basis subject to approval of the parent department. The work and conduct of the officer will be reviewed every year by the Administrative Secretary. The officer will be repatriated if his performance is found unsatisfactory.

7. EMPLOYEES NOT TO BRING UNDUE INFLUENCE

Any attempt by any candidate to influence the selection procedure will automatically make him ineligible for the said post. Action will also be initiated against such employee under relevant Service Rules/Employees Conduct Rules including an entry to this effect in his/her service record.


It is, therefore, requested that the vacancy may be given wide publicity and particulars of eligible officers who are fulfilling the eligibility prescribed and are willing to be considered for deputation may be forwarded to the Additional Chief Secretary to Government, Haryana, Power Department, Haryana Civil Secretariat, Chandigarh within the prescribed date. The application should contain summary of ACRs for last 10 years (should be Very Good/Outstanding), certificate from the parent department in respect of satisfactory work & conduct, pending inquiry/ disciplinary proceeding/vigilance inquiry, if any. The Departments and agencies may do due diligence whether they will be willing to spare the candidates for the said post of deputation.
