Subject:- Regarding filling up two posts of Assistant Research Officer in Research Unit of Administrative Reforms Department in Haryana Civil Secretariat on transfer basis.

2 It is informed that two posts of Assistant Research Officer (Group 'C') is in the Pay Matrix, Schedule-I, Level-6 of Haryana Civil Services (Revised Pay) Rules, 2016 are proposed to be filled up in Administrative Reforms Department (in Research Unit), Haryana Civil Secretariat on transfer basis amongst the Government employees of Haryana Government having following qualification and experience:-

(iv) Master's degree in Economics or Agricultural Economics or Mathematics or Commerce from a recognised University with at least 55% Marks and Statistics as one of the papers at the Master's level;

Or

Master's degree in Statistics or Operation Research from a recognized University with at least 55% Marks;

Or

Master's degree in Public Administration with at least 2nd Division from a recognised University.

(v) One year experience of collection, compilation and analysis of Statistical data on the post having pay matrix level -6 in the State of Haryana.

(vi) Knowledge of Hindi/ Sanskrit upto Matric Standard or Higher Education.

Note:- Preference will be given to candidates having basic knowledge of Computer operation (MS Word, MS Excel, Power Point etc.

3 You are requested to forward the application of suitable, willing and eligible candidates alongwith their curriculum vitae to Establishment-I Branch, 05th floor, Haryana Civil Secretariat, Chandigarh, who can be spared immediately on selection and the same may be **sent to the undersigned within 30 days from the date of issue of this circular** alongwith the following documents:-

- v) **Clear Photostat copies of their ACR for the last 10 years i.e. from 2012-2013 to 2021-2022 duly attested by Gazetted officer.**
- vi) **Integrity Certificate.**
- vii) **Certificate confirming that no disciplinary/ vigilance case pending or being contemplated against the officer.**
- viii) **A statement showing major or minor penalties, if any, imposed on the applicant during the last 10 years.**

Application received after the closing date or without the Photo state copies of ACR duly attested by a Gazetted Officer or without recommendation of the concerned office or otherwise found incomplete are liable to be rejected. While forwarding the applications, it may be verified the certificate and particulars furnished by the official are correct in all respect. It may also be confirmed that in the event of selection, the official concerned will be immediately relieved to join his/ her new assignment.
