I have been directed to invite your attention to the subject mentioned above and to state that the Government has decided to empanel the following new private hospitals for providing treatment to the Haryana Government employees/pensioners and their dependents:

3. To provide seamless and hassle free services to Haryana Govt. Employee/Pensioners and their dependents, the empanelled private hospitals shall extend all normal courtesies and facilitate the admission, treatment and discharge of Haryana Govt. beneficiaries with no delay or denial of medical facility.
4. A Nodal Officer shall be appointed at level of empanelled private hospitals. The Nodal will communicate with the concerned Civil Surgeon or/ and department in case of any grievance.
5. In case of any emergency/disasters/overflow of patients in Govt. Hospitals during epidemics the empanelled hospitals will agree to share their ambulances, mortuary, ICU/CCU, burn unit, ward beds etc. in need based manner.

6. All statutory Rules/Guidelines/Acts/Notifications issued by State Govt. from time to time (As already mentioned in the application form for New Empanelment Policy) shall be followed by the empanelled hospitals.
7. The hospitals will abide to all the National Programmes and its related H.C activities. The data needed for National Program or Health Indicators must be shared with Health Department.
8. The hospitals shall follow the birth & death guidelines issued by the State Government from time to time. Any software developed by the Govt. will have to be adopted by the hospitals.
9. It will be the responsibility of the hospitals to provide accreditation certificate and further renewal certificate as per Govt. Empanelment policy in place and amended from time to time.
10. Guidelines already framed under State Govt. policy dated 21.05.2015 now & as revised from time for empanelled hospitals shall be applicable. The empanelled hospitals shall abide to all guidelines of Empanelment policy.
11. The empanelled hospitals will provide Limited Cashless Medical Facility notified by State Govt. Dated 20-11-2017 & amended 04-04-2018.
12. It will be responsibility of the hospitals to provide the renewed Entry Level NABH/Full NABH/JCI certificate within in the expiry of previous certificate. If they are enable to provide such certificate then it will be de-empanelled automatically.
13. The above listed Full NABH hospitals will remain empanelled for period of three years subject to validity of accreditation certificate. Thereafter, the hospital will apply afresh. The above listed Entry Level NABH Hospitals will remain empanelled for a period of one year subject to validity of accreditation certificate. The Entry Level NABH Hospitals will have to get full NABH accreditation within one year of empanelment failing which these hospitals will automatically stand de-empanelled without giving any prior notice.
14. Health Department reserves the right to call for record of treatment of any patient from any empanelled hospitals to ensure no mal-practise takes place.
15. The reimbursement on expenditure incurred on package procedure for treatment taken in Entry Level NABH hospitals will be allowed on Non NABH rates as per Haryana Govt. policy dated 21.05.2015 and non package treatment will be allowed at PGI Chd. Rates+75% of the balance amount.
16. The reimbursement on expenditure incurred on package procedure for treatment taken in Full NABH hospitals will be allowed on NABH rates as per Haryana Govt. policy dated 21.05.2015 and non package treatment will be allowed at PGI Chd. Rates+75% of the balance amount
16. All empanelled hospitals will maintain record of the treatment of the patients.
17. Vide Govt. Policy dated 03-07-2019, if private empanelled hospitals gets disqualified/de-empanelled under "The Haryana Clinical Establishment(Registration and Regulation) adoption Act, 2018" shall be automatically de-empanelled from the list of Haryana Govt. No. Separate intimation/notice shall be issued.
18. Vide Govt. Policy dated 03-07-2019, if private empanelled hospitals gets disqualified/de-empanelled under the list of services of "The Pradhan Mantri Jan Aarogya yojna (PMJAY)/Ayushman Bharat Scheme, shall be automatically de-empanelled from the list of Haryana Govt.
19. These instructions will be applicable from the date of issue of this letter, instructions may be downloaded from the Health Department Web Site (<http://haryanahealth.nic.in>.)


