NOTE:-

- 1. The admissibility regarding landline service for XENs and Sr. AOs will be as per O/o No: 97/2005/06/Fin/HPGC dated 26.07.2005.
- 2. The above entitlement i.e. monthly usage charges amount is inclusive of data services/broadband services or any other service charges along with the calls on the landline telephone as well as all taxes, duties levies etc.
- The above entitlement is irrespective of entitlements of others services like mobile & data card.
- The data services/broadband services on the landline telephones can be availed by the employees on the official residence landline with the rider that any bill exceeding the entitled limit would be borne by the employee from his/her pocket.
- The employee concerned can avail the landline telephone and Broadband facility of any service operator i.e. BSNL/Airtel/Connect etc. as per their feasibility at their own level. The one-time cost in respect of installation charges /instrument charges except security charges in case of new connection shall be borne by HPGCL.
