In exercise of powers conferred under section 56(3)(vi) of Haryana Electricity Reforms Act, 1997 read with Electricity Act, 2003, Article 48 of the Articles of Association of HPGCL and all other enabling powers in this behalf the Haryana Power Generation Corporation Limited is pleased to amend the Regulation-10 of the PSEB Service of Engineering (Electrical) Regulation, 1965 (as applicable in HPGCL) notified vide office order No. 35/REG-25A/PSEB dated: 01.09.1965 and others amendments thereof governing the recruitment and conditions of service of persons appointed to the extent as under:

Appointment by Direct
Recruitment (Electrical)**

The vacant posts of Assistant Engineer (Electrical) meant for direct recruitment in Nigam would be filled up on the basis of Score of GATE (Graduate Aptitude Test in Engineering) examination being conducted by one of the Indian Institutes of Technology every year subject to fulfillment of conditions laid down in regulation-8 of PSEB Services of Engineering (Electrical) regulation 1965 and amended from time to time.

Proposed provision**Regulation-10
Appointment by Direct Recruitment (Electrical)**

The vacant posts of Assistant Engineer (Electrical) meant for direct recruitment in Nigam would be filled up on the basis of Score of GATE (Graduate Aptitude Test in Engineering) examination being conducted by one of the Indian Institutes of Technology every year and Socio economic criteria and experience subject to fulfillment of conditions laid down in regulation-8 of PSEB Services of Engineering (Electrical) regulation 1965 and amended from time to time.

The weightage of GATE score, marks of experience and socio economic criteria shall be allocated as under:

a)	Weightage of Gate Score (The normalized GATE marks (out of 100) would be converted/scaled out of 80 Marks by multiplying with 0.8)	80 Marks
b)	Socio economic criteria and Experience	20 Marks
	Total of (a+b)	100 Marks

The marks for experience and some objective socio-economic criteria shall be allocated as follows:

- (a). If neither the applicant nor any person from among the applicant's family viz. father, mother, spouse, brothers, and Sons is, was or has been a regular employee in any Department/Board/ Corporation/ Company/ Statutory Body/ Commission/ Authority of Government of Haryana or any other State Government or Government of India. (10 Marks)

- (b) If the applicant is:-

- A widow; or
- The first or the second child and his father had died before attaining the age of 42 years; or
- The first or the second child and his father had died before the applicant had attained the age of 15 years. (10 Marks)


- (c) If the applicant belongs to such a denotified tribe (Vimukt Jatis and Tapriwas Jatis) or Nomadic tribe of the state of Haryana which is neither a schedules Caste nor a Backward Class. (10 Marks)

(d) Experience: One mark for each year or part thereof exceeding six months of experience, out of a maximum of sixteen years, on the same or a higher post in any Department/ Board/ Company/ Statutory Body/ Commission/ Authority of Government of Haryana.

No Marks shall be awarded for any period less than six months.
(Maximum of 16 Marks)

Note: No applicant shall be given more than 20 marks for socio-economic criteria and experience under any circumstances.
