**Sub:- Empanelment of Ojas Super Speciality Hospital, Sector-26, Panchkula with HVPNL at PGI rates/ package rates notified by the Government of Haryana, Health Department vide notification dated 21.05.2015.**

In pursuance to the approval by Board of Directors, HVPNL in its meeting held on 28.03.2018, OJAS Super Speciality Hospital, Sector-26, Panchkula is hereby empaneled with HVPNL for the treatment of the Nigam's employees/ retirees & their dependents at PGI rates/ package rates notified by the Government of Haryana, Health Department vide notification dated 21.05.2015. The balance medical expenses, if any, would be borne by the concerned employee/ retiree.

2. OJAS Super Speciality Hospital, Sector-26, Panchkula would also provide the following discounts to the Nigam's employees/ retirees & their dependents for medical treatment:-

- i) 10% discount will be given on all surgeries other than 154 surgeries as notified by the Government of Haryana, Health Department vide notification dated 21.05.2015.
- ii) 20% discount on OPD charges/ Consultation charges in the OJAS hospital, Sector-26, Panchkula.
- iii) 20% discount on all laboratory tests done in the OJAS hospital, Sector-26, Panchkula.
- iv) 5% discount on all the medicines purchased from the OJAS hospital, Sector-26, Panchkula on the prescription of the Doctors of the HPUs and for indoor patients of the HPUs in OJAS hospital, Sector-26, Panchkula.






