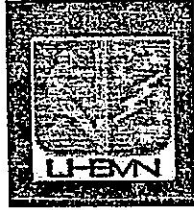

DAE of Engineering Cadre shall comprise of four (4) papers as under:

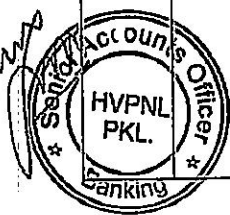
