Regarding fixation of pay in the revised pay structure where promotion/Increment/ACP falls between 01.01.2016 to 28.10.2016-Re-excercise of option.

I am directed to draw your attention to the subject mentioned above and to the provisions contained in Rule 6 & 17 of HCS(Revised Pay)/(ACP) Rules, 2016, with regard to exercise of option for fixation of pay in the revised pay structure for the employees between 01.01.2016 and 28.10.2016.

Cases are being received from the various departments for grant of relaxation under relevant Rules to re-exercise the option between 01.01.2016 and 28.10.2016.

The matter has been re-considered at length and it has been decided that an employee, who had earlier exercised option between 01.01.2016 and 28 10.2016 is allowed to re-exercise his/her option under Rule 6 or 17 of HCS(RP)/(ACP) Rules, 2016 with the following conditions:

- 1. The excess amount paid if any to the employee on the basis of option exercised earlier, shall be recovered/adjusted.
- 2. This fresh and final option will be re-exercised within three months from the date of issue of these instructions.
- 3. No request for condoning delay in exercising the fresh option will be entertained and no further chance will be allowed by the Finance Department.

These instructions may be brought to the notice of all concerned for strict compliance.
