Subject : Regarding amendments/revisions requests on live/concluded tenders on Single e-Procurement Portal, Haryana.

This is in continuation of this office letter no. 12260-12342 dated 22.11.2018, on the subject noted above.

It is again to inform you that recently, the Principal Accountant General, Haryana has conducted the IT Audit to check the Transparency, Integrity & Security of the Single eProcurement portal being managed by M/s Nextender. During the IT Audit of the portal, it has been observed that number of amendments were made in live tenders by the departments on the portal just before last date of submission of bids or after the last date on the ground that they did some error/ mistake while uploading/submitting the tender. The Principal Accountant General, Haryana has raised strong objection to this procedure.

Therefore, no amendments/ revisions should be made/requested in live tenders on Single eProcurement portal. In case, concerned Government agency require any amendments/ revisions in live tenders, they should upload a corrigendum well in advance or recall tender with the correct information.

It is further requested to check & carefully upload the tender details, to avoid any type possibility of mistake for the smooth functioning of eProcurement system.

You are requested to bring it to the notice of all concerned for compliance.
