2. I am directed to refer to Haryana Government, Health Department letter No.2/363/1998-IHBIII dated 27-01-2009 vide which the rate of the Fixed Medical Allowance to the Haryana Government employees/pensioners /family pensioners was increased to Rs. 500/- per month. Subject: Special Allowance for Child Care to differently abled female Government Employees.

In the welfare of differently abled female employees, the State Government has decided to introduce the Special Allowance for Child Care to female Government Employees who are differently abled, on the basis of the recommendations of 7th Central Pay Commission and the recommendations of Allowance Revision Committee with the following conditions:-

1. The rate of special allowance shall be Rs.1500/- (Rs. one thousand five hundred only) per month per eligible child.
2. This allowance shall be effective from 01.05.2018.
3. This allowance shall be admissible to all the female Government Employees with disability of 40% and above as certified by an authority entitled to issue such a certificate as per CSR.
4. This allowance is applicable to disable female employee being mothers of children who are either young or with disability.
5. This allowance shall be admissible to be paid with respect to a maximum of two eldest surviving children.
6. This allowance shall be admissible for two years only, to be paid to the female Government Employees to claim it from the birth of such a child and up to the time such child attains an age of two years.

Subject: Revision of rates of Non-Practising Allowance.

Whereas rates of Non-Practising Allowance to doctors working in the Health Department, Animal Husbandry and Dairy Development Department and Ayush Department (AMO/UMO/HMO) were revised vide Finance Department letter No. 1/19/2009-1PR (FD) dated 20.02.2009 on the basis of the recommendations of 6th Central Pay Commission.

Now, the State Government has decided to revise the existing rates of Non-Practising Allowance at the rate of 20% (twenty percent) of Pay in Pay Matrix in the revised pay structure to the doctors working in the Health Department, Animal Husbandry and Dairy Development Department and Ayush Department (AMO/UMO/HMO), with the following conditions:-

1. The Government Employee posted against a clinical post and actually working against such a post alone is eligible to draw this allowance.
2. The Government Employee posted against a whole time post alone is eligible to draw this allowance.
3. The Government Employee in whose case there is ample scope of undertaking private practice alone is eligible to draw this allowance.
4. This allowance shall be admissible only in such cases and circumstances where it is necessary to prohibit private practice in public interest.
5. The sum of the Pay+ NPA shall not exceed Rs.224550/- (Rs. Two lakh twenty four thousand five hundred and fifty only) per month.
6. The revised rates shall be effective from 01.05.2018.
7. Other terms and conditions shall remain unchanged.

The Non-Practising Allowance shall be treated as part of pay for the purpose of DA, entitlement of loans and advances and TA/DA only.

I am directed to draw your attention towards Rule 13(ii) of HCS (RP) Rules, 2016 and Rule 21(1) of HCS (ACP) Rules, 2016, which provides that:

“On enhancement in presumptive pay of feeder post due to increment or otherwise while working on promotional post/ACP, the pay of promotional/ACP post shall be re-fixed as if the incumbent has been promoted on the date of such enhancement, if it is advantageous to him, as provided in rule 4.14(2) of Punjab Civil Services Rules Volume-I Part-I,

Some queries have been received in the Finance Department that, where under rules 13(ii) and Rule 21(1), the presumptive pay of the feeder post is higher on getting annual increment (on the due date) after the date of promotion/ ACP than the pay already fixed on promotion/ACP, whether the benefit of re-fixation of pay is available or not?

It is clarified that, it is amply clear from the said provision that on enhancement in presumptive pay of feeder post due to next increment, the pay of such employees will be re-fixed giving the benefit as provided under Rule 13(ii) of HCS (RP) Rules, 2016/ Rule 21(1) of HCS(ACP) Rules, 2016 assuming that the employee has been promoted/granted ACP on 1st January/1st July i.e. after acquiring annual increment. One example for fixation of pay in such type of cases is as under:-

Fixation of pay of Mr. 'A' on his promotion from Steno-typist to Jr. Scale Stenographer granted ACP from Level 2 to Level 4.
