ORDER

The Governor of Haryana is pleased to Constitute a Screening Committee under the Chairmanship of the Chief Secretary to Government Haryana as under:-

- a) Chief Secretary to Government, Haryana Chairman
- b) Administrative Secretary of the Department(s) Member
to which the proposal relates.
- c) Special Secretary to Government of Haryana, Member
General Administration Department.

2. The said committee shall examine each proposal/reference relating to relaxation of Model Code of Conduct before sending it to Election Commission through the Chief Electoral Officer, Haryana, in the light of Commission's existing instructions/clarifications available in the form of compendium/instruction.

3. The proposals to be submitted to Screening Committee should clearly contain-
- (i) The urgency of the matter.
 - (ii) Reasons, why the proposal in question could not wait till completion of election process.
 - (iii) Whether any level playing field is disturbed,
 - (iv) The provision of Model Code of Conduct, in which the relaxation is required.

4. The CEO shall forward only such proposal(s) that are cleared by the aforesaid Screening Committee, to the Commission along-with his/her comments immediately. Hence, all departments of the State are advised not to forward any reference directly to the Commission. Further, no department of the Government shall send original file to the Screening Committee/CEO's office but only a self contained reference be sent through the Screening Committee.

5. The proposals to be sent to CEO, Haryana after clearance by Screening Committee should be sent online by uploading on cViGIL app of the Election Commission of India. Password & User Ids provided to Administrative Secretary during the recently concluded Election may be used.
