**Subject:** Policy regarding reimbursement of dental procedures for Haryana Govt. Employees, Pensioners and their dependents.

Sir/Madam,

It is stated that the State Government Haryana has decided to implement the Policy regarding reimbursement of 31 dental procedures for Haryana Government employees, pensioners and their dependents in Government Health Facilities including Govt. Medical Colleges, District Hospitals and in all private hospitals/medical colleges, empanelled with State Govt. on outdoor basis.

2. The salient features of the Policy are, as follows:-

- I. The Policy is applicable to regular Haryana Govt. Employees and Pensioners and their dependents. The contractual/ outsourced employees under Haryana Govt. are not entitled under this scheme.
- II. The Policy is applicable for only thirty one (31) dental procedures on outdoor basis, as mentioned in the table below:

- III. The Haryana Govt. Employees and Pensioners and their dependents shall surrender the option of availing Fixed Medical Allowance and change to open medical allowance to avail the reimbursement of above mentioned dental procedures on OPD basis. Once the claimant opts for Open Medical Allowance, the same shall remain to be continued for a period of two years.
- IV. For the dental procedures not covered under the Para II above, the beneficiary will bear the expenses at his own and no reimbursement would be allowed for the same.
- V. This policy is applicable at all Govt. medical colleges/ Govt. aided medical colleges in Haryana, all district hospitals, other health institutions of Haryana Government, and all private hospitals/medical colleges/dental clinics, empanelled with State Govt. from time to time (A list is available on the website of Health Department i.e. haryanahealth.nic.in).
- VI. The private medical colleges/hospitals, including dental clinics would be empanelled as per the existing State Government Empanelment Policy.
- VII. All the Departments/ Boards/ Corporations of State Govt. shall issue valid Identity cards to their regular employees, pensioners to entitle them for availing reimbursement of dental procedures on OPD basis. The pensioners shall carry the PPO (Pension Pay Order). These will be accepted as proof of identity by all the Government/ Private empanelled health facilities for providing treatment facilities to them.
- VIII. It is the responsibility of the beneficiary to produce the valid Identity Card/ PPO No./ Aadhaar Card to the hospital in order to establish his/her identity of being regular employee/pensioner/dependent.
- IX. It is the responsibility of health institutions to ask for the Identity cards/PPOs/Aadhaar card of the employees/ pensioners/ dependents and to explain them, whether the dental procedure/surgery, required for their treatment, is covered under reimbursement policy for dental procedures or not.
- X. In case any fake bill or duplication of claim is reported, the beneficiary/institution is liable to be penalized for major penalties under the Haryana Civil Services (Punishment and Appeal) Rules, as amended from time to time. In case, any wrong bill/fake treatment is reported and confirmed, the hospital is liable for de-empanelment. It is the responsibility of concerned department to send such case, along with details/proofs, to Health Department for taking necessary action.
