HPGCL is pleased to empanel:-

1. All the branches of those hospitals having wide network across the country i.e. Apollo Hospital, Medanta Hospital, Fortis Hospitals, Metro Hospital, Max Hospitals Naryana Hardiyalya Hospitals, Shankar Netralya, Paras Hospitals, Park Hospital, Columbia Asia Hospitals, Amrita Hospitals & Mayo Hospitals etc. irrespective of their locations.
2. All the hospitals/diagnostics empanelled by respective State Govt/U.T. across the country for taking treatment/diagnostics of HPGCL employees/retirees and dependents.

The reimbursement shall be strictly made that:-

- i. Hospitals/diagnostics centres having NABH/NABL credential, package rates fixed by the Govt. of Haryana shall be applicable. However, if, treatment does not fall in the package rates, then PGI Chandigarh rates, + 75% of the balance amount shall be reimbursed for the same.
- ii. Non NABH/NABL credential Hospitals/diagnostics centre, PGI, Chandigarh rates shall be applicable.
- iii. In case, the hospital/diagnostics centre charges over and above the package rates fixed by the Govt., Haryana, reimbursement shall be made as per package rates fixed by the State Govt., Haryana for NABH/NABL credential hospitals/diagnostics centres & PGI, Chandigarh rates for non NABH/NABL credential hospitals/diagnostics centres. The balance amount shall be borne by the respective employee/retiree/dependent.
