Subject: RSA No. 568 of 2006 titled as HVPN & Ors V/s Santro Devi.

The aforesaid case came up for hearing on 29.11.2025 and the Hon'ble High Court vide judgment dated 29.11.2025 has dismissed the present matter holding that family pension can be granted to the widow/dependents only in case the deceased employee was regularized. The relevant part of the judgment dated 29.11.2025 is reproduced here under:-

- “11. In view of the above, it is settled law that family pension can be granted to the widow/dependents only in case the deceased employee is regularized.
12. In view of the above, the regular second appeal is allowed. Judgment and decree dated 02.06.2005 passed by Additional Civil Judge (Sr. Division), Gohana and judgment and decree dated 05.11.2005 passed by Additional District Judge, Sonapat are set aside.
13. Pending application(s), if any, also stand disposed of.”

It is important judgment on the issue that family pension is admissible only if the deceased employee was regularized. It is therefore, requested to circulate the judgment amongst the subordinate offices under your control for disposal of similarly situated case by placing reliance on the aforesaid judgment. A copy of judgment dated 29.11.2025 is enclosed herewith for ready reference.
