Reference Finance Department's earlier instructions bearing No. 11/148/2022-1FR/27294 dated 18.01.2023, No. 11/148/2022-1FR/8869 dated 03.05.2023 and No. 11/148/2022-1FR/27693 dated 31.01.2024 on the subject noted above.

2. The matter has been re-considered by the Government and after consideration of the matter related to grant of honorarium, the Government has taken following decisions:-

- i) Payment of honorarium to employees from Financial Year 2025-26 onwards shall be considered strictly as per provisions contained in Rule 50 to 53 of Haryana Civil Services (Allowances to Government Employees) Rules, 2016.
 - ii) No relaxation will be granted in ibid Rules.
 - iii) Instructions bearing No. 11/148/2022-1FR/27294 dated 18.01.2023, No. 11/148/2022-1FR/8869 dated 03.05.2023 and No. 11/148/2022-1FR/27693 dated 31.01.2024 issued by Finance Department regarding guidelines for grant of honorarium are hereby withdrawn.
