The Haryana State Cooperative Labour & Construction Federation Ltd., Panchkula, being Apex Federation of these societies, circulated copy of the said notification vide letter no. HSCLCF/Gen/2025/461-510 dated 03.07.2025 (Copy enclosed) to all Head of Departments. However, various representations have been received from field that the reservations and concessions mentioned in the notification are not being implemented in letter and spirit by many departments due to which the purpose of issuance of notification is being defeated.

In this regard, it is pertinent to mention that Hon'ble CM, Haryana has set the target for allocation of government work worth approx. Rs. 4000 Crores to these Primary Labour & Construction Societies in Budget Announcements for 2026-27. The copy of relevant page of Budget Announcement is also enclosed herewith for ready reference.

In view of the aforementioned position, you are earnestly requested to implement the Haryana Govt. Notification bearing no. 480-C-7-2025/4728 dated 27.06.2025 in your Department by issuing directions to your field offices and provide the benefits to these societies as per the provisions contained in the said Notification.

In continuation of Haryana Government, Cooperation Department, Notification No. 1214-C-7-2022/2747, dated 20/05/2022, the Governor of Haryana hereby extends the following concessions/facilities to the Cooperative Labour and Construction Societies in the State of Haryana from 01st April, 2025 to 31st March, 2030 :-

1 (a)	All works (skilled/unskilled) costing upto Rupees One Crore will be reserved for Cooperative Labour and Construction Societies upto the rates allotted in the immediate past for similar works after inviting tenders for the concerned circle of the P.W.D.
(b)	These concession shall also be applicable to the contract relating to supply of manpower, loading and unloading of goods, transportation of goods and supply of construction material.
(c)	In case Cooperative Labour and Construction Societies fail to tender or do not accept the works, then open tenders may be invited from both the Contractors and Cooperative Labour & Construction Societies.
2 (a)	The Cooperative Labour & Construction Societies will make payment of earnest money of Rs. 25000/- or 1% whichever is less for works upto Rs. 50.00 Lacs and for works beyond Rs. 50.00 Lacs, earnest money will be 50% of the earnest money applicable to the contractors.
(b)	Performance Security for Cooperative Labour and Construction Societies shall be half of the performance security applicable to contractors for works upto any value. In case of the Cooperative Labour and Construction Societies consisting of all members who are women or those who belong to Scheduled Caste, the performance security will be 25% of the performance security applicable to contractors.
3 (a)	Preference in making payment shall be given to Cooperative Labour and Construction Societies whenever letter of Credit (L.C.) received.
(b)	The District Central Cooperative Banks shall provide credit limit to the Primary Cooperative Labour and Construction Societies against tangible security as per banking norms and societies who avail such facility shall maintain their account with the concerned District Central Cooperative Bank only.
4.	The work of sanitation in Govt. Hospital and in Urban Local Bodies shall be reserved upto 60 Lacs for Cooperative Labour & Construction Societies consisting of all women members or all Scheduled Caste members. In case, Cooperative Labour & Construction Societies fail to tender then open tenders may be invited from both the Service Provider and Cooperative Labour & Construction Societies.

5.	The Cooperative Labour and Construction Societies shall be exempted from any Licensing Fee/Enlistment Fee.
6.	The concessions granted to Cooperative Labour and Construction Societies at point no. 1, 2, 3 & 5 will also apply to work relating to semi Government, Local Government, Public Sector Corporations, Improvement Trusts, Marketing Board, Housing Board, Haryana Police Housing Corporation, Haryana Tourism Corporation, Haryana Vidyut Prasaran Nigam, Haryana Power Generation Corporation, Uttar Haryana Bijli Vitran Nigam, Dakshin Haryana Bijli Vitran Nigam, HSHDC, Haryana State Roads and Bridges Development Corporation, Haryana Rural Roads and Infrastructural Development Agency, HUDA/HISVP, ICDP, Panchayati Raj Department, CADA, HAFED, Warehousing Corporation and works relating to World Bank Aided Projects, all other work allotment agencies and other Statutory Bodies etc.
7.	The copy of the tender notice issued by any Work-Awarding-Agencies will also be forwarded to the District Cooperative Labour and Construction Federation as well as Assistant Registrar, Cooperative Societies concerned for their information.
8.	Arbitration cases between Cooperative Labour and construction Societies and work awarding agencies (other than any cooperative society/members) shall be decided as per the provisions contained in Haryana P.W.D. Code.
9.	The Cooperative Labour and Construction Societies enlisted with the Principal Department i.e. anyone of the three branches of Public Works Department, need not be further enlisted with other departments, Corporation, Local Government, Semi-Government Undertaking etc.
10.	The District Co-ordination committee on Cooperative in each district shall be constituted by the Government to review the allocation of works to the Labour and Construction Societies, to expedite the payments from Works-Awarding-Agencies, to review the cases of arbitration and all such other matters relating to working of the Labour Cooperatives in the light of above concessions.
11.	All Work-Awarding-Agencies shall deduct or cause to be deducted the contribution amount payable at the rate specified by Registrar, Cooperative Societies, Haryana from time to time (at present 1%), from every work bill on Net payment of Primary Cooperative Labour and Construction Societies. The Contribution amount so deducted shall be credited by the payment making agency in the account of the Haryana State Cooperative Labour and Construction Federation Limited, Panchkula. All such payment making agency/work awarding agencies may deduct/charge the actual administrative/collection charges not exceeding 3% of the total so deducted and collected contribution amount.

12. All Work-Awarding-Agencies shall prepare the monthly statement consisting details i.e. name of Society, total work done, payment of contribution amount and administrative charges with date and forward the same to the District Cooperative Labour and Construction Federation concerned.

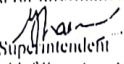

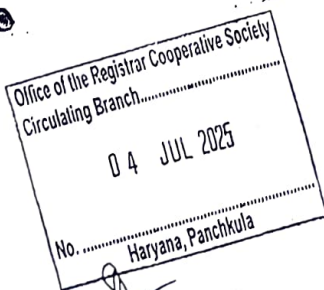

welcome any suggestions for additional works that could be included in the agenda of Gram Sabha meetings.

Inspired by the Hon'ble Prime Minister's mantra of "**Sehkar Se Samriddhi**," the Hon'ble Union Minister of Home Affairs and Cooperation, Sh. Amlt Shah Ji, has launched 57 initiatives nationwide to harness the immense potential of the cooperative sector in generating self-employment and promoting overall development. Today, out of our 804 PACS, only 33 are making profit. The computerization of all PACS is underway. Many PACS have now expanded into activities such as Common Service Centers (CSCs), PM Kisan Samriddhi Kendras, Jan Aushadhi Kendras, LPG and petrol pumps, as well as agricultural marketing and storage. Through these efforts, PACS are transforming into multi-purpose, economically empowered, profitable, and employment-generating organizations, including ventures in new businesses like petrol pumps. I have set a target to bring at least 300 loss-making PACS into profit in 2026-27.

At present, more than 9,000 labour and construction cooperative societies function in the state. Last year, government construction projects worth approximately ₹1,000 crore were allocated to these societies. However, around 6,000 societies remain completely inactive. To connect interested and educated youth, we will organize seminars and webinars in ITIs and polytechnic institutes. I propose allocation of government work worth approximately ₹4,000 crore to these societies in 2026-27.

I believe these three proposals will revitalize these institutions and harness the energy of thousands of youth across Haryana.

Last month, under the Haryana AI Mission, a state-of-the-art "**AI Sandbox**" was established in the State which is identifying and validating cases in key sectors such as agriculture, health, education, and the environment, where AI can enhance departmental services. An '**Innovation Challenge**' will be held in May 2026 to select the best AI teams and successful models will be implemented in the respective departments starting November 1, 2026.
