Sub: **Regarding for confirm & change of syllabus of Ministerial Cadre (Paper-VI).**

Kindly refer to your office memo No. Ch.3734/CAO/HPGCL/Exam/SO/Vol-9 dated 14.10.2021 vide which the query regarding Paper-VI of Ministerial Cadre i.e. LDC of HPGCL was forwarded to this office which is reproduced as under:-

"It is requested that the syllabus of Department Accounts Exam of Ministerial Cadre should be updated because there is doubt in Paper No. VI of Ministerial Cadre for Conduct regulation or Employee Punishment & Appeal Regulation-2016 and conduct regulation 1984 or Employee Punishment & Appeal Regulation-1980 that the syllabus will be given out of above regulations in the ministerial exam. But our department has adopted employee conduct regulation & Employee punishment & appeal regulation-2016, through the departments letter number Ch.06/HPTI-322/Vol-II dated 08.09.2020 the syllabus of Engineering/Engineering subordinates of all HPUs has been revised. But there is still doubt about the syllabus of the ministerial cadre. Therefore, I request you to tell us clearly which syllabus will be given in our paper that is conduct Regulations & employee punishment & appeal regulation-2016 and conduct regulation 1984 & employee punishment & appeal regulation-1980"


In this regard, it is intimated that the request application was sent to THE Chief Coordinator, UIAMS, Panjab University, Chandigarh vide this office Endst. No. Ch.97/HPTI-322/Vol-II dated 08.11.2021 for taking further necessary action at their end.

UIAMS, Panjab University, Chandigarh has intimated vide ref No. UIAMS/Ex 4506 dated 09.11.2021 which is reproduced as under:-

"It is not possible to implement any change in syllabus of Paper-IV at this stage as the question paper have already been got set. However, in case your subject experts recommend some change in syllabus, it may be got approved from the competent authorities well in advance and be communicated to us officially for future exam. Hence the representation put forth by the candidates merits no consideration"

It is therefore requested to kindly intimate the concerned officials of HPGCL of the Ministerial cadre for their information.
