In exercise of powers conferred under Section 56(3) of Haryana Electricity Reform Act, 1997 read with Electricity Act, 2003 and all other enabling power in this behalf the Haryana Power Generation Corporation Limited is pleased to make the following amendments in Regulation - 4, 21 (3) & 22 of HSEB Allotment of Residential Accommodation Regulations, 1980 (Applicable for HPGCL) vide office order dated 11.07.1980 read with office order no. 31/REG-59 dated 08.01.2007 and office order no. 153/CE/Admn dated 27.09.2016 to the extent as under:-

Regulation-21: Charges Payable for the accommodation beyond the entitled period:

<p>Regulation 21(3): The employees on deputation (except those in BBMB) would also be liable for the charges for retention beyond permissible limit as applicable to retirees for the accommodation.</p>	<p>Regulation 21(3): a. The employees working on deputation in any Govt. department (except those in BBMB) would be allowed to retain accommodation beyond entitled / permissible period, with a condition that borrowing department shall deposit HRA + License fee from the employee on deputation. b. The Competent authority to allow retention of accommodation of officer/official on deputation beyond the entitled period shall be as per Regulation 25 amended vide order dated 02.08.2018, i.e. CE/Admin upto two years and WTDs beyond two years after permissible period.</p>
