PUC (<u>Page-30</u>) is letter Ref No. UIAMS/Ex 4174 dated 04.03.2021 received from UIAMS, Panjab University, Chandigarh vide which it has been intimated as under:

"That sample Question Paper-I, III & IV has already be collected by your office representative on 1st March, 2021. However, a minor discrepancy has arisen in the revised syllabus for paper-II for the above Examination with regard to maximum marks. The syllabus has been formulated with 105 as max. marks whereas maximum marks should not be more than 100 as per previous syllabus.

It is requested that the matter be placed before the competent authorities/committee for rectification etc."
