
In this context, the date for submission of applications of Departmental Accounts Examination for various cadres is hereby extended up to **14.11.2025**, as under: -

NO APPLICATION WILL BE ACCEPTED AFTER LAST DATE i.e. 14.11.2025.
- b) The applications on the prescribed Performa (**Annexure-A**) received through Competent/Cadre Controlling Authority shall only be accepted and the **applications sent directly to this office will be rejected straightway without any communication/back reference.**
- c) Roll Number and Date sheet of the candidates will be supplied subsequently.
