Sub:- Notification of Departmental Accounts Examination for various cadres i.e. Engineering, Ministerial & Account Cadre of HPUs to be conducted on outsourced basis through National Institute of Technology (NIT), Kurukshetra.

A Memorandum of Understanding (MoU) was signed on dated 03.08.2022 between National Institute of Technology (NIT), Kurukshetra & HVPN Power Training Institute (HPTI) on behalf of all Haryana Power Utilities (HPUs) i.e. HVPNL, HPGCL, UHBVNL & DHBVNL for conducting of Departmental Accounts Examination of its various cadres i.e. Engineering Cadre, Ministerial Cadre and Accounts Cadre.

2. National Institute of Technology (NIT), Kurukshetra has informed that the Departmental Accounts Examination (DAE) of various cadres of HPUs can be conducted during the month of December-2024/January-2025.

3. It is therefore, requested to issue necessary directions to the concerned offices for arranging Application Forms of the eligible candidates who intend to appear in Departmental Accounts Examination for various cadres i.e. Engineering, Ministerial & Accounts Cadres (SO Part-I, SO Part-II, Section Officer 'directly recruited incumbent') & Account Officer. The particulars filled by the candidates in his/her Application Forms as per prescribed proforma be got verified & approved by the concerned Competent/Cadre controlling authorities of the Power Utilities.

The filled Application Forms complete in all respect of eligible candidates **along with soft copy of consolidated list of the total candidates in Excel as well as PDF format may kindly be sent to this office through Competent/Cadre Controlling Authorities** of respective Power Utilities, latest by **10.11.2024**, so as to enable this office to process & forward the same to NIT, Kurukshetra well in time.

5. Moreover, the important information regarding the Departmental Accounts Examination (DAEs) is as under: -

- a) Last date for submission of Application Forms of candidates to HPTI through competent/Cadre Controlling authorities of HPUs is **10.11.2024**.
NO APPLICATION WILL BE ACCEPTED AFTER THE LAST DATE.
- b) The applications on the prescribed Performa (**Annexure-A**) received through Competent/Cadre Controlling Authority shall only be accepted and the **applications sent directly to this office will be rejected straightway without any communication/back reference.**
- c) Roll Number and Date sheet of the candidates will be supplied subsequently.
