In this context, it is intimated that Computer Test for the directly recruited Candidates against the posts of Section Officer, Divisional Accountants & Junior Accountants of all HPUs shall be conducted tentatively in the month of June, 2023 at HVPN Power Training Institute (HPTI), Sector-26, Panchkula.

Therefore, it is requested to issue necessary directions to the concerned offices for arranging application forms of the eligible candidates who intend to appear in the Computer Test. The particulars given by the candidates in his/ her application as per prescribed Performa be got verified from their service records by the Competent Authority. - 2. The applications on the prescribed Performa (Annexure-A) received through Competent/Cadre Controlling Authority shall only be accepted and applications sent directly to this office will be rejected straightway without any communication/ back reference.
- 3. Applications Fee of Rs. 590/- per candidate (For Paper I & II of Computer Test) plus GST@18% is required to be deposited in advance along with the application forms of the eligible candidates by the concerned Power Utilities through RTGS/NEFT/PAY ORDER/ Banker's Cheque in favour of "HVPN POWER TRAINING INSTITUTE" payable at Panchkula.
- 4. Roll Number and Date sheet of the candidates shall be supplied subsequently.
