

1. Last date of submission of application form is 31.05.2023 and no application will be accepted after the same.
2. The applications on the prescribed Performa (**Annexure-A**) received through Competent/Cadre Controlling Authority shall only be accepted and applications sent directly to this office will be rejected straightway without any communication/ back reference.
3. Applications Fee of Rs. 590/- per candidate (For Paper I & II of Computer Test) plus GST@18% is required to be deposited in advance along with the application forms of the eligible candidates by the concerned Power Utilities through RTGS/NEFT/PAY ORDER/ Banker's Cheque in favour of "HVPN POWER TRAINING INSTITUTE" payable at Panchkula.
4. Roll Number and Date sheet of the candidates shall be supplied subsequently.
