i) Haryana Civil Services (General) Rules, 2016

Adopted except Chapter-IV regarding classification of services, creation of post, conduct and Discipline and Punishment & Appeal as HPGCL has its own Recruitment & Promotion Policies of all cadre exists in HGPCL, Punishment and Appeal Regulations and Employee Conduct Regulations.

ii) Haryana Civil Services (Pay) Rules, 2016

Adopted except Chapter- XIV- Rule-71 (Treatment of Resignation from service for the purpose of pay Fixation & Rule-74 (Appointment from an organization to any department under Haryana Government or vice- versa).

- iii) Haryana Civil Services (Allowances to Govt. Employees) Rules,2016
 Adopted with the following amendments:
 - i) Except Chapter-III i.e grant of cycle allowance to Group 'D' employees, conveyance Allowance to Medical officer, Conveyance Allowance to Personal Assistant & Private Secretary and Chapter-IV i.e. recovery of License Fee and Rent of Government Accommodation.
 - The allowances prevailing in HPGCL other than the allowance notified by the State Government in its referred order i.e. Local Out-door Duty Allowance, Free Electricity Allowance, Shift Duty Allowance, Cash Handling Allowance, Hardship Allowance and all other allowances on the projects, field and head office etc. shall remain unchanged in pursuance to provisions contained in Haryana Government Power Department notification dated 14.08.1998 (Haryana Electricity Reforms Act, 1997). Further, the HPGCL allotment of Residential Accommodation Regulations shall also remain effective.
