In this regards, it is intimated that the performa of application form for appearing in Departmental Accounts Examination for SO Part-I, SO Part-II & Accounts Officer has been upload on HVPNL website (www.hvpn.org.in) and same can be downloaded from the ibid site. It is requested to arranging application forms of the eligible candidates who intend to appear in Departmental Accounts Examinations. The particulars given by the candidates in his/her application as per prescribed Performa (Annexure-I) be got verified form their service records by the competent Authority working under your control. The application forms complete in all respect of eligible candidates along with soft copy of the candidates may kindly be sent to this office through the Cadre Controlling Authority, latest by 10.09.2021, So as to enable this office to forward the same to Panjab University well in time.

Further, it is also intimated by Director Principal, HPTI that the registration is mandatory for appearing in Departmental Accounts Examination of all candidate. If any candidate fails to provide registration number in application form, Roll. No. will not be issued. However, if candidates are applying first time for Departmental Accounts Examination or not applied till date then in addition to application form for appearing in Departmental Accounts Examination candidate have to submit duly filled up and signed application form (Annexure-II) with registration application form (Annexure-III) along with supportive documents to this office immediately through cadre controlling authority.

Sub:- Notification of Departmental Accounts Examination for SO Part-I, SO Part-II & AO for all Haryana Power Utilities to be conducted on outsource basis through UIAMS, Punjab University, Chandigarh.

It is informed that, as per memorandum of understanding (MoU) signed on dated 05.08.2013 between UIAMS, Panjab University, Chandigarh & HVPN Power Training institute and this office order no. 56/HPTI-344 dated 12.02.2020, the Departmental Accounts Examination for SO Part-I, SO Part-II & AO was to be conducted by UIAMS, Panjab University, Chandigarh tentatively in the month of March/april, 2021. But due to Covid-19 Pandemic, Departmental Accounts Examination for SO Part-I, SO Part-II & AO could not be conducted.
