Sir/Madam,

I am directed to refer to the subject noted above and to say that a copy of Letter No. SEC/IME/2022/1666, Dated 23.05.2022 received from State Election Commission Haryana vide which the attention of Hon'ble Chief Minister/ Deputy Chief Minister/Ministers /Ministers of State has been invited to strictly follow the model code of conduct during the programme of General Elections for the seat of President and Members of all the wards of 28 Municipal Committees and 18 Municipal Councils which will be held on 19.06.2022. The Model Code of Conduct prescribed by the State Election Commission has come into operation with w.e.f 23.05.2022 in the areas of municipalities where the poll is to be held.

2 Attention is also invited towards Para No. 9 of the Model Code of Conduct that no grant be sanctioned by them from the discretionary fund or from the Govt. fund nor they will sanction any scheme / plan till elections process are completed in all respect. During this period, neither any foundation stone shall be laid nor will any scheme / plan be launched in the respective areas. Any violation of the Model Code of Conduct will be viewed seriously by the State Election Commission. A copy of the Model Code of Conduct in this regard is also available on the Commission's website www.secharyana.gov.in. It is requested that this may be brought to the notice of the Hon'ble Chief Minister, all Ministers, MPs/ MLAs, Chairpersons (Non Official) and other authorities of all Boards/ Corporations.
