Subject: Regarding filling up backlog of vacancies for PwDs in terms of PwD Act, 1995 and RPwD Act, 2016.

Sir/ Madam,

I am directed to invite your attention on the subject cited above and to say that in the fourth meeting of Central Advisory Board on Disability, held on 26.11.2020, it has been observed that backlog of vacancies meant for persons with disabilities are required to be filled up through special recruitment drive.

- 2. The matter has been considered by the State Government and it has been decided that data of backlog for persons with disabilities in direct recruitment for Group A, B, C and D posts may be worked out as per reservation @ 3% with effect from 01.01.1996 under "Persons with Disabilities (Equal Opportunities, Protection of Right and Full Participation) Act, 1995" and reservation @ 4% with effect from 17.12.2016 under "The Right of Persons with Disabilities Act, 2016". It has also been further decided to launch a special recruitment drive for Persons with Disabilities (PwD) in case of direct recruitment for Group- A, B, C and D so that adequate representation of PwDs in all group may be ascertained.
- 3. The Department shall workout on the backlog of all posts of direct recruitment reserved for Persons with disabilities in Group A, B, C & D and send the requisition of vacancies for persons with disabilities to the recruiting agencies i.e. Haryana Public Service Commission and Haryana Staff Selection Commission or other recruitment agency as per the provision in Service Rules applicable. The HPSC /HSSC or other recruitment agency shall advertise the vacancies immediately under the special recruitment drive.
- 4. These instructions may please be brought to the notice of all concerned for strict compliance.
