- i. Nigam/Corporation Candidates of HPUs in order to be eligible for direct appointment as Assistant Engineer are also required to qualify in the corresponding paper of GATE- 2022 or GATE- 2023 or GATE- 2024 or GATE- 2025.
- ii. The Nigam/Corporation eligible candidates of HPUs are required to apply online and shall forward copy of print out of their online application form to respective existing cadre controlling authority of his/her Utility through proper channel on or before **04-11-2025**.
- iii. Nigam/Corporation candidates of HPUs should upload a copy of the ID card issued by respective Haryana Power Utility, during submitting online application form.
- iv. The names of only such eligible Nigam/Corporation candidates of HPUs forwarded by respective HPUs shall be considered for selection. Mere forwarding of name does not make an employee eligible for selection.
- v. Nigam/Corporation candidates of HPUs are not exempted from Application fee.
- vi. In case of selection of Nigam/Corporation candidate, no benefit of past service rendered in Nigam/Corporation will be admissible. He/ She will be treated as fresh entrant for all intent and purposes.

The applications of the Nigam/ Corporation Candidates shall be forwarded by HPUs on or before 12.11.2025 (5:00 P.M). The applications received thereafter shall not be considered.
