Sub: MBA Course in Power Management: Willingness of AEs/AEEs and XENs thereof.

In this context, it is intimated that the Board of Directors of HVPNL in its meeting held on 10.08.2021 deliberated in detail the agenda item no.198.24 w.r.t. HVPNL training policy/ MBA in Power Management and it has been decided that Director Principal, HPTI will compile the data of the officers of the rank of AE/AEE and XEN of Haryana Power Utilities who wish to pursue MBA course in Power Management and report of the compiled data shall be submitted to the Management within one month.

It is further informed that HPTI, Panchkula has been pursuing the matter with MDI, Gurugram in respect of Post Graduate Diploma in Power Management and it has been conveyed that the institute is in process to finalize the curriculum of the Post Graduate Diploma in Power Management which may be commenced tentatively from July, 2022 as per the regulatory norms with duration period of 15-18 months either online or hybrid mode (Online as well as Classroom).

In view of the above, it is therefore, requested to provide the detail of the officers of the rank of AE/AEE and XEN of Haryana Power Utilities who wish to pursue MBA course in Power Management to this office by 20.09.2021 after seeking willingness from the officers, so that a consolidated report may be submitted for the appraisal of the Worthy ACS Power-cum- Chairman, Haryana Power Utilities.
