



Subject: Purchase of Medicines for Chronic disease on existing prescription.

In continuation to this office letter no. Ch-137/SCM/Genl. Dated 26.5.2021 vide which it has been allowed to purchase medicines and to get annual investigation/ disease related relevant investigation done for chronic disease on existing prescription without getting it repeated from the Government approved hospital/HPU Health centre on 31.12.2021.

In Field, retirees/employees are faces problem for reimbursement of medicines purchased on the existing prescription of Government approved hospital/ HPU Health centre. The Doctor Incharge/DDO is insisting on to get the bill countersigned from the hospital.

Since patients were allowed to purchase medicines on existing prescription without getting it repeated from the hospital, the Medical Supdt. / Doctor of the concerned hospital is not bound to verify the claim.

Moreover, if we asked the Sr. Citizen to visit the hospital for getting the medical claim countersigned from the Medical Supdt. / Doctor of the concerned hospital, this will expose them to Covid -19 infection and the purpose for which the ealier instruction were issued will be defeated.

Therefore, it is clarified that reimbursement of medicines purchased on existing prescription or charges of annual investigations or disease related relevant investigation may be verified without insisting on to get medical reimbursement bill countersigned of the Medical Supdt./Doctor of the concerned hospital. Necessary instructions may be issued to all concern and it may be uploaded on official websites of the Nigams.
