

The appointment on deputation on foreign services terms including short-term contract basis shall be made initially for a period of three years and regulated in accordance with instructions contained in the Govt. of India, Department of Personnel & Training OM No. 6/8/2009-Estt. (Pay II) Dtd 17.06.2010, as amended from time to time.
- iii. The eligibility of such candidates who are working in PSUs or other Govt. Organizations where Industrial/ Variable Dearness Allowance pattern is applicable, shall be determined by equating their IDA/VDA pattern pay scale with the requisite CDA pattern pay scales as being normally done.
- iv. The age of the candidate shall not exceed 56 years as on last day of submission of application.
- v. The Commission reserves the right not to fill the above-mentioned vacancy.
- vi. No correspondence with the applicant shall be entertained as regards to fulfilling of eligibility criteria.
- vii. All applicants should have fulfilled the minimum eligibility on the date of application. 
