In view of above, it is intimated that the performa of application form for appearing in Depa tmental Accounts Examination for Engineering Officers & Subordinates staff has been upload on HVPNL website (www.hvpn.org.in) and same can be downloaded from the ibid site. It is requested to submit application forms of the eligible candidates who intend to appear in DAE for Enginee ing Officers & Subordinates staff latest by 15.08.2021 positively (in hard as well as soft copy). The particulars given by the candidates in his/her application be verified from their service records on the prescribed performa (Annexure-I).

Further, it is intimated by Vice, Principal, HPTI that the registration is mandatory for appearing in Departmental Accounts Examination of all cadres. If any candidate fails to provide registrat on number in application form, Roll. No. will not be issued. However, if candidates are applying first time for Departmental Accounts Examination or had not applied till date then in addition to application form for appearing in Departmental Accounts Examination candidate have to subm t duly filed up and signed application from (Annexure-II) with registration application form (Annexu e-III) along with supportive documents to this office immediately through cadre controlling authority.
