**Subject:- HBA, Conveyance, Marriage, Computer, Wheat and Festival Advances to Government Employees- Under Suspension or against whom proceedings are pending under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016.**

Sir,

I am directed to refer to the aforementioned subject and to state that instructions have been issued from time to time by the Finance Department regarding grant of advances to Government employees for HBA, Conveyance, Marriage, Computer, Wheat and Festival purposes.

Now, the Government has decided that no application for the purpose of grant of aforementioned advances shall be entertained and no advance shall be sanctioned or disbursed to Government employees who are under suspension or against whom proceedings are pending under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 which are likely to result in his/her removal, dismissal or compulsory retirement from Government Service.
