Age for entry into Government service or to compete for regular recruitment and relaxation in age under various circumstances.

Sir/Madam,

I am directed to invite your attention to the subject cited above and to say that Government has decided to issue consolidated instructions in supersession of all the instructions already issued by Government regarding fixation of lower and upper age limit for entry into Government service or to compete for regular recruitment and also regarding grant of relaxation in upper age limit under various circumstances (previous instructions that are superseded are listed at Annexure-A).

- Government has considered the matter and decided as below:
 - The minimum age of a person for entry into Government service shall be 18 years and maximum age shall be 42 years in respect of the posts of all Groups A, B, C & D in addition to the age relaxation prescribed herein for various categories.
 - ii) Age relaxation for various categories is as under:-

Sr. No.	Categories where relaxation is admissible	No. of years of relaxation

(iii)	Wives of military personnel who are disabled while in military service.	5 years

*For Ex-serviceman: For appointment of an ex-serviceman to a post of Group A, B, C or D, his/her age will be calculated keeping in view the actual age minus (actual period of military service plus three years). If the resultant age does not exceed the maximum age limit prescribed for the post for which he/she is seeking appointment he/she shall be deemed to satisfy the condition regarding age limit.

- Until necessary amendment is made in the rules by the Finance Department, these
 instructions shall be applicable with immediate effect instead of the provision which exists in Rule 22
 of the Haryana Civil Services (General) Rules, 2016.
