In partial modification in the rules governing the re-imbursement/ entitlement prescribed in the Office Order no. 201/CE/Admn dated 24 03.2022 regarding providing need base Mobile handset and mobile service facility to the contractual drivers working at Corporate office. HPGCL, Panchkula, are as below .

- The drivers will submit their bill of mobile handsets & monthly bills to their a) concerned offices & then concerned office will forward duly verified and approved bills to the Accounts Section, HPGCL for payment,
- The contractual drivers permitted to purchase the mobile phone at prices higher b) than the permissible / entitled limits, subject to re-imbursement restricted to permissible limits
- The replacement of mobile phone be allowed only after completion of two years c) from the date of earlier purchase of mobile phone.
- If any contractual driver leaves the job then he will hand over the mobile to the d) HPGCL. However, if he leaves the job without intimation to the department then the residual value of mobile handset will be deducted from his forthcoming salary The method of working out the residual value is prescribed in the office order dated 24 03.2022
- If any post of driver stand terminated then driver will be allowed to retain the phone e) on deposition of residual value of mobile handset.
- The entitlement and admissibility for purchase of mobile handset and for availing Note: mobile service facility i.e. monthly usage charges remains same as prescribed in the ibid Office Order dated 24.03.2022.
