Clarification- Recovery on account of reduction of pay while fixation of pay in terms of HCS (RP) First Amendment Rules, 2020 and HCS (ACP) First Amendment Rules, 2020.

I am directed to draw your kind attention towards Haryana Civil Services (Revised Pay) First Amendment Rules, 2020, notified vide notification no. 1/20/2016-5 PR (FD) dated 14th of July, 2020, whereby, vertical cells of FPL- 14 and FPL-15 under Schedule 1 were substituted. Further, vide another notification bearing even no. and date, Haryana Civil Services (Assured Career Progression) First Amendment Rules, 2020 were also notified and vertical cells of ACPL-18 and ACPL-19 in Schedule-A were substituted. The said notifications were effective w.e.f. 01.01.2016.

Now, a query has been received that due to re-fixation of pay according to notifications dated 14.07.2020 of Haryana Civil Services (Revised Pay/ Assured Career Progression) First Amendment Rules, 2020, the pay of the employees has been reduced than the pay fixed earlier.

The matter has been examined in the Finance Department. After careful consideration, it has been decided that:-

If the pay re-fixed strictly as per the Haryana Civil Services (Revised Pay) First Amendment Rules, 2020 or the Haryana Civil Services (Assured Career Progression) First Amendment Rules, 2020 happens to be lower than that of pay entitlement under pre-amended respective rules (as notified vide notifications dated 28.10.2016), any recovery of overpayment on account of such re-fixation w.e.f. 1.1.2016 to 31.07.2020 shall be waived.

It is also clarified that, the above clarification should not be applied with any recovery, which specifically arises due to initial revision/ pay fixation against the provisions of notifications dated 28.10.2016 (i.e. HCS (RP) Rules, 2016 or HCS (ACP) Rules, 2016) and action for such recovery should be taken as per applicable Rules.

It is also informed that, HCS (RP) First Amendment Rules, 2020 and HCS (ACP) First Amendment Rules, 2020 have been further amended vide notification dated 6th July, 2021. Amended vertical cells of FPL-14 and FPL-15 under Schedule I of HCS (RP) Rules, 2016 and vertical cells of ACPL-18 and ACPL-19 under schedule 'A' of HCS (ACP) Rules, 2016 are attached herewith as Annexure- 'A'
