Payment of Statutory Bonus to the employees of HPGCL for the FY 2022-23, under Payment of Bonus Act, 1965.

HPGCL is pleased to sanction payment of statutory bonus @ 8.33% of the salary/wages to the eligible employees of the HPGCL for the FY 2022-23 in accordance with the provisions of the Payment of Bonus Act, 1965 as amended to date.

- The ceiling limit with respect to salary / wages for employees to become eligible to earn bonus will remain maximum to Rs. 21,000/- (Rs. Twenty one thousand only) for
- The ceiling limit with respect to bonus to employees who are eligible to earn bonus 3. will remain maximum to Rs. 7,000/- (Rs. Seven thousand only) for the FY 2022-23.
- The employees shall be eligible for Bonus provided that he has worked in the 4. establishment for not less than 30 working days in the year 2022-23 in accordance with the provision of Section 8 of the Payment of Bonus Act, 1965.

- It may be ensured that the payment of bonus for the year 2022-23 is invariably made 6. before 30.11.2023, in accordance with the provisions of Section 19 of the Payment of Bonus Act, 1965.
